

**Entry procedures
for foreigners who are married to/ or children of Thai nationals**

Foreigners who are married to Thai nationals or foreigners who are children of Thai nationals with an urgent need to travel to Thailand. Applications will be considered on a case-by-case basis, taking into account urgency and humanitarian reasons.

1. At least 15 working days before intended date of travel, the applicant may submit information online. [Click here](#)
2. Royal Thai Consulate-General submits documents in 1. to the Ministry of Foreign Affairs for approval.
3. If approved, the Royal Thai Consulate-General will inform the applicant to mail the following documents to the Royal Thai Consulate-General in Los Angeles, (Attention : Visa Section)
 - 3.1 Passport
 - 3.2 Two passport-size photographs (2"x 2")
 - 3.3 Visa application form (Download)
(if the applicant does not have a valid visa to enter Thailand)
 - 3.4 Declaration Form
 - 3.5 Medical insurance or letter from employer guaranteeing that the insurance company or employer will cover a minimum of 100,000 USD (or equivalent in other currencies) of medical costs incurred by the applicant in Thailand, including medical costs in the event that applicant contracts COVID-19.
 - 3.6 Travel plan (air ticket reservation – please contact the Consular section per Thai nationals' repatriation flights)
 - 3.7 Copy of recent bank statement (700 USD per person/ 1,500 USD per family)
 - 3.8 Provide reasons for urgent need to travel to Thailand.
 - 3.9 Copy of spouse's / parent's Thai passport or Thai Identification card.
 - 3.10 Proof of relationship with Thai nationals, such as a copy of marriage certificate or Birth certificate.
 - 3.11 Self-addressed return envelope and visa fee (Money order- \$80 for single entry / \$200 for multiple entries) if the applicant does not have a valid visa.

4. Before the Consulate issues the Certificate of Entry (COE), the applicant must upload
 - 4.1 Travel plan (confirmed air ticket with proof of payment),
 - 4.2 Fit to Fly health certificate (72 hours before departure date),
 - 4.3 COVID-19 health certificate (test negative) (72 hours before departure date); and
 - 4.4 Confirmation of ASQ.

The applicant must arrange their own 14-day Alternative State Quarantine (ASQ) at their own expenses. More information, including list of permitted hotels (in Thai) can be found here at <http://hsscovid.com>

5. At the departure airport, the approved applicant is required to present
 - 5.1 A “Certificate of Entry” issued by The Royal Thai Consulates-General;
 - 5.2 A Declaration form;
 - 5.3 A “Fit to Fly Health Certificate” issued no more than 72 hours before departure;
 - 5.4 A “Covid-free Certificate” issued no more than 72 hours before departure;
 - 5.5 Medical insurance or letter from employer guaranteeing that the insurance company or employer will cover a minimum of 100,000 US dollars (or equivalent in other currencies) of medical costs incurred by the applicant in Thailand, including medical costs in the event that applicant contracts COVID-19.
6. Upon entry to Thailand, Travelers arriving in Thailand during the COVID-19 pandemic must submit a T.8 form upon entry into the Kingdom.
